The meeting of the City of Fincastle was called to order at 6:35pm at the Hope Evangelical Lutheran Church, 4200 Shenandoah Drive.

Present: Mayor John Bell, Commissioners: Ollie White, Gene Harris, Jr., Samuel Jackson and Jerry Gregory, Treasurer/Clerk Jean Reid. The guests were city residents and the website administrator.

**APPROVAL OF MINUTES**

The minutes of the regular meeting 12-11-25 were reviewed. Commissioner Jackson moved to accept the minutes as presented, Commissioner Harris seconded, motion passed unanimously.

**TREASURER'S REPORT**

Jean Reid presented the treasurer's report

All balances are from bank statements. Larger expenses were for new light poles in Halifax common area and city attorney bills. Commissioner Harris moved to accept the treasurer report subject to audit, Commissioner Jackson seconded. All vote aye, motion passed unanimously.

The Mayor called for a second reading of ORDINANCE NO. 5, SERIES 2026 by title and summary, as read by the City Clerk:

ORDINANCE 5, SERIES 2026, AN ORDINANCE OF THE CITY OF FINCASTLE, KENTUCKY AMENDING ORDINANCE NO. 2, SERIES 1985 GOVERNING THE PARKING OF MOTOR VEHICLES AND THE CONSTRUCTION OF DRIVEWAYS. Commissioner Gregory moved to accept the second reading of the ordinance, Commissioner White gave a second. Voting aye: Commissioners White, Harris, Jackson, Gregory, Mayor Bell, none vote no, motion passed. Commissioner Gregory moved to adopt ORDINANCE NO. 5, SERIES 2026. Commissioner White seconded. Voting aye: Commissioners White, Harris, Jackson, Gregory, Mayor Bell, none voting no, motion passed.

The Mayor advised the city will be getting a credit from T-Mobile for past charges for the dialpad once all city phones are activated and on the dialpad.

The recent Houser Lawn & Landscaping bill reflects materials and labor for 27 new stop signs. They were not aware the mayor had already purchased the signs and was reimbursed by the city for \$635.88 on 2-13-25. Mayor Bell advised he would return the signs to Amazon and return the \$635.88 to the city.

Voting aye Mayor Bell, Commissioners White, Harris, Jackson, Gregory, none voting no, motion passed.
