## APPROVAL OF MINUTES

The minutes of the regular meeting 7-10-25 were reviewed. Commissioner Harris moved to accept the minutes as presented, Commissioner Jackson seconded, motion passed unanimously.

All balances are from bank statements. Larger expense for the month was for insurance policy renewals, \$7,726.82 for liability and property coverages. \$807.39 interest earned on the money market account. Second Q 2025 insurance premium taxes coming in and starting to receive 25/26 property taxes. Commissioner White moved to accept the treasurer report subject to audit. A second came from Commissioner Jackson. With a roll call vote, motion passed unanimously.

Commissioner Gregory seconded. A roll call vote was held. Voting Aye: White, Harris, Gregory, Jackson, Voting Nay, none, motion was approved unanimously. Commissioner Harris moved for a first reading of Ordinance 3, Series 2025, AN ORDINANCE (A) REPEALING ORDINANCE NO. 2, SERIES 1998 CREATING A PAY SCALE FOR ELECTED OFFICIALS; AND (B) FIXING AND ESTABLISHING MONTHLY COMPENSATION FOR THE ELECTED OFFICE OF MAYOR. Commissioner White seconded. A roll call vote was held. Voting Aye: White, Harris, Gregory, Jackson and Bell. Voting Nay: none, motion was approved unanimously.

A code enforcement board was discussed.
