**APPROVAL OF MINUTES**

The minutes of the regular meeting 8-14-25 were reviewed. Commissioner Gregory moved to accept the minutes as presented, Commissioner Jackson seconded, motion passed unanimously.

**TREASURER'S REPORT**

Jean Reid presented the treasurer's report

All balances are from bank statements. Documents were sent and approved to receive funds for HB413 during 25/26 fiscal year. \$843.34 interest was earned on the KLCIP money market account. Preparing the required 2025 Unaudited Financial Statement for DLG, by due date October 1, 2025. Commissioner Harris moved to accept the treasurer report subject to audit, Commissioner Gregory seconded. All vote aye, motion passed unanimously.

**OLD BUSINESS**

Commissioner Harris moved for the second reading of Ordinance No. 2, Series 2025, AN ORDINANCE (A) REPEALING ORDINANCE 94-07 ESTABLISHING PAY LEVELS FOR THE CONTRACTORS OF THE CITY OF FINCASTLE, KENTUCKY AND (B) FIXING AND ESTABLISHING MONTHLY COMPENSATION FOR CITY

CLERK/TREASURER. Commissioner Gregory seconded. A roll call vote was held. Voting Aye: White, Harris, Gregory, Jackson, Bell. Voting Nay, none, motion was approved unanimously. Commissioner White moved to pass Ordinance No. 2, Series 2025, Commissioner Jackson seconded. Voting Aye: White, Gregory, Harris, Jackson, Bell. Voting Nay: None, motion was approved unanimously.

Commissioner Jackson moved for a second reading of Ordinance No. 3, Series 2025, AN ORDINANCE (A) REPEALING ORDINANCE NO. 2, SERIES 1998 CREATING A PAY SCALE FOR ELECTED OFFICIALS; AND (B) FIXING AND ESTABLISHING MONTHLY COMPENSATION FOR THE ELECTED OFFICE OF MAYOR.

Commissioner Harris seconded. A roll call vote was held. Voting Aye: White, Harris, Gregory, Jackson and Bell. Voting Nay: none, motion was approved unanimously.

Commissioner Gregory moved to pass Ordinance No. 3, Series 2025, Commissioner Jackson seconded. Voting Aye: White, Harris, Gregory, Jackson, Bell. Voting Nay: none, motion was approved unanimously.

Electrical work is needed at the front entrance. Commissioner Harris is tasked with researching pricing on 2 new light poles.

#### NEW BUSINESS

Commissioner Harris moved that the city should hold its annual Octoberfest community gathering on Saturday, October 18, 2025 from noon to 5PM with a budget not to exceed \$4,500. Commissioner Gregory seconded. Roll call vote with Commissioner White and Mayor Bell abstaining. Voting Aye: Harris, Gregory, Jackson. Voting Nay: none, motion passed.

#### OPEN FLOOR

Residents are concerned about on-street parking, stop signs and tree damage.

#### ADJOURNMENT

The mayor called for a motion to adjourn at 7:40pm. Commissioner Gregory moved to adjourn, Commissioner Jackson seconded, the motion passed unanimously.
