OLD BUSINESS

It was decided to cancel the Octoberfest for this year due to the rise in COVID-19 cases and possibly do a Spring Fling, if conditions improve. Last month a request was made to have clerk review prior minutes regarding a survey that was done on the Murphy Lane frontage. Clerk Reid located minutes from August 12, 2010, taken by Commissioner Godfrey in the clerk's absence. Legal Report indicating a survey was done at the Murphy Lane frontage to determine property lines. This was done by Bob Isgrigg & Associates for \$400., however, the clerk did not find one retained in the minutes. Perhaps it is located within then Mayor Howson's files.
